Waiver and Release Agreement for Recreational Diving
READ CAREFULLY BEFORE SIGNING!!

I, (print name) _____, hereby affirm that I am a certified diver, that I understand all the inherent dangers of Skin and Scuba Diving, and know the basic safety rules for underwater activities.

I desire to dive with the Naval Air Station Jacksonville (NASJAX) Skin and Scuba Diving Club, Inc., its officers, members, and/or designees (hereinafter known as NASJAX Dive Club/NASJAX Divers), who sponsor diving related activities, recreational diving and social activities. This waiver will be effective from the date signed until December 31, of that calendar year.

I agree to furnish my own equipment and will be responsible for its good operating condition regardless of where I obtain such equipment. I agree further that prior to each dive I will check my own equipment, my dive-buddy's equipment to ensure proper function, completeness and familiarity. I do not expect my equipment to be inspected by the NASJAX Dive Club/NASJAX Divers.

I understand that the NASJAX Dive Club Divers may provide advice, or assistance to me, and agree to hold harmless the NASJAX Dive Club/NASJAX Divers and club officers for any of their actions in attempting to be of assistance to me. I will not hold the NASJAX Dive Club/NASJAX Divers or club officers responsible for supervising my diving activities in any way. **BY SIGNING THIS DOCUMENT, I ASSUME ALL RESPONSIBILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH, EVEN IF CAUSED BY THE NEGLIGENCE OF OTHERS.**

I understand, and agree, that my recreational diving activities with the NASJAX Dive Club/NASJAX Divers will not be credited in any way toward my training requirements for any level of diving certification and that my diving activities with the NASJAX Dive Club/NASJAX Divers are entirely of a recreational nature.

I have read, understand and agree to abide by the NASJAX Dive Club Dive Policy and NASJAX Dive Club Safety Rules during these recreational diving activities.

I understand, and agree, I am participating in these recreational diving activities voluntarily, and I agree to be completely responsible for my own actions.

I hereby declare I am of legal age and am competent to sign this waiver and release agreement or if I am a minor, my Parent/Guardian can sign this document on my behalf.
